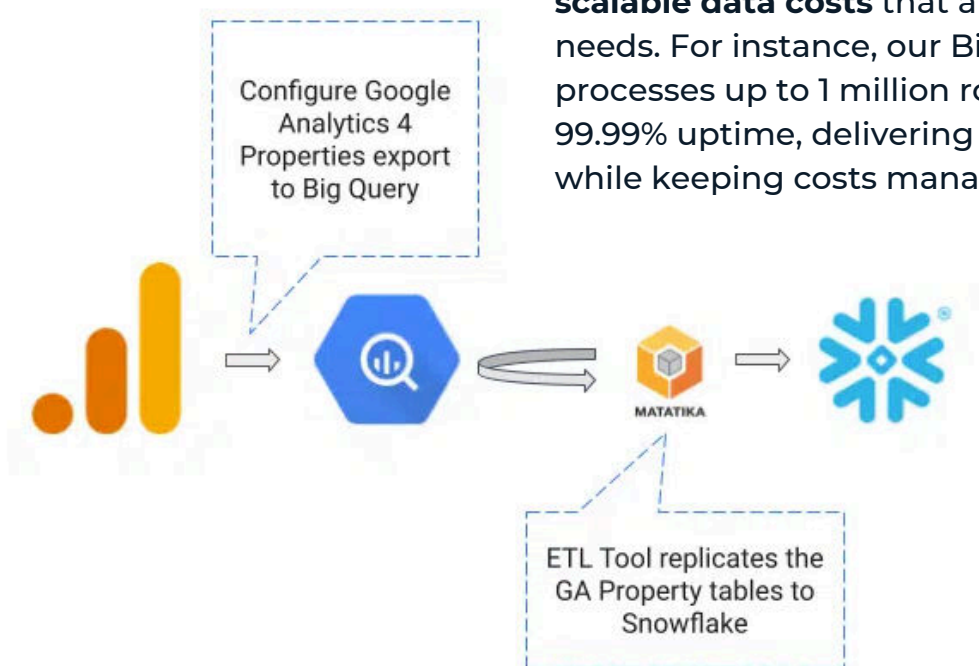

Here's how Matatika's cost-based pricing stacks up against traditional ETL platforms like Fivetran, which rely on row-based pricing models

Example GA4 to Snowflake Integration

In this example, a marketing team processes **10 million click events per day**, equating to **300 million rows per month**, using Snowflake for their campaign analytics. To manage this data effectively, they use a Big Query export from GA4.

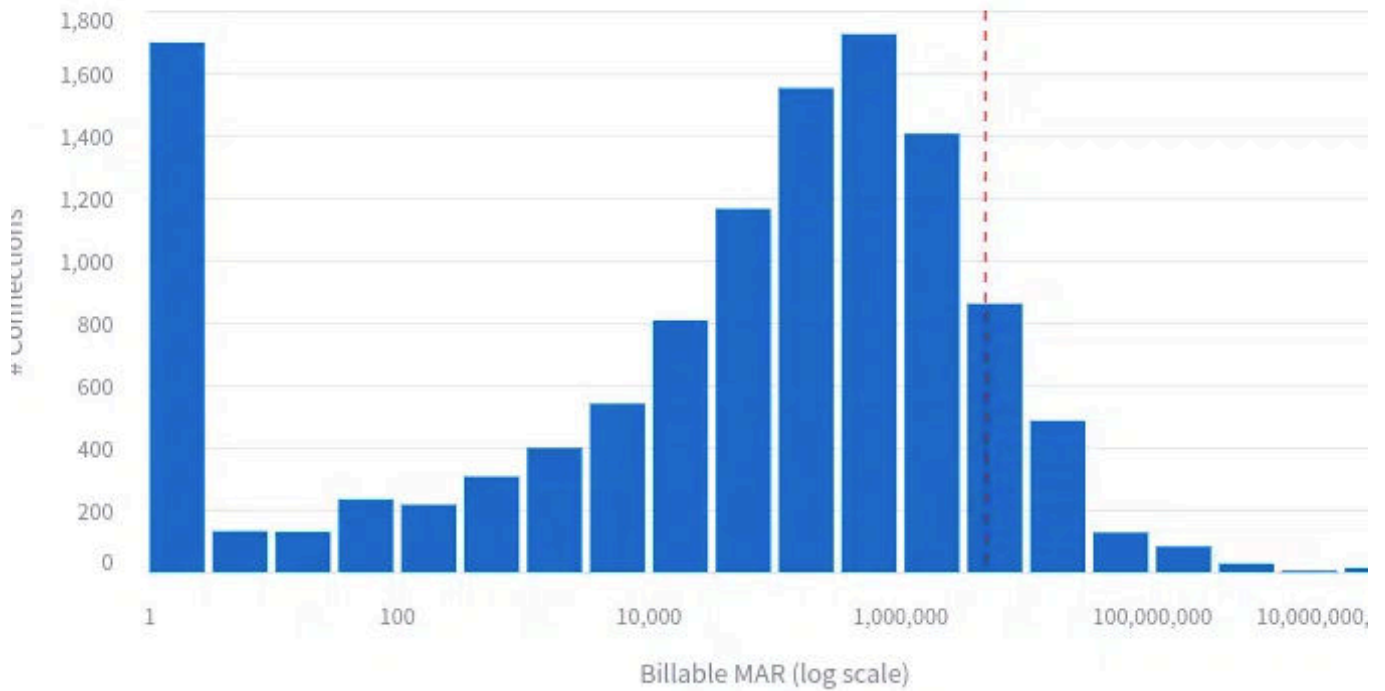
Platform	Rows per Month	Monthly Cost	Time to Load
 Fivetran	300 million rows	£9,339.25/month	14 minutes/day
 MATATIKA	300 million rows	£6.49/month	12 minutes/day

Fivetran – Row-based Pricing

With Fivetran's row-based pricing, the cost for processing 300 million rows is **£9,339.25 per month**. As data volumes increase, so does your bill—even if the additional rows don't provide extra insights or value.

Matatika – Cost-based Pricing

By contrast, Matatika charges only for infrastructure usage, reducing the cost for the same data load to **£6.49 per month**, a 99.4% saving. Even with Matatika's full-service plan priced at £999/month, businesses still save 89% compared to Fivetran, with no hidden fees or unexpected increases.
